

## Celebrating the LLSR with Dr. Edward Ward

Out of 37,000 dentists in the Academy of General Dentistry, only 154 members have achieved the Lifelong Learning & Service Recognition (LLSR) since its inception in 2005. The 154th LLSR recipient is our very own Dr. Edward Ward.

The LLSR is presented only to AGD members who have gone above and beyond earning the association's highest honor of Mastership. To accomplish this recognition, Dr. Ward completed at least 1,600 hours of continuing dental education in 16 different dental disciplines and at least 100 hours of dental-related volunteer service.

Dr. Ward graduated from the Oregon Health & Science University School of Dentistry in 1977 and currently practices dentistry in Portland. In addition to the AGD, Dr. Ward is a member of the American Dental Association, the Oregon Dental Association, the National Dental Association, the Academy of Cosmetic Dentistry, the Multnomah Dental Society, the Oregon Association of Minority Entrepreneurs, the National Association for the Advancement of Colored People, the Veterans of Foreign Wars, and the Society of Children's Storybook Writers and Illustrators. Additionally, he serves as a board member at both Carrington College and Anthem College, as well as an adjunct professor at Portland Community College. Dr. Ward and his wife, Barbara Diane, have two children, Edward E. Ward Jr. and Kelli Elizabeth.

### **Why did you want to become a dentist?**

After receiving a bachelor's degree in Medical Technology, I realized that interacting with people was important to me. I found laboratory research very repetitive and uninspiring. Dentistry provided an avenue for self-expression, creativity, interacting with the public, and contributing to the health and wellbeing of others.

### **Why did you join this organization?**

Dr. Bill Howard recommended my joining the OAGD. Unaware of all the benefits the OAGD provides to its members, I initially joined to keep track of my CE hours. I recommend dentists take time to examine a complete fee schedule or the list of procedures found in the CDT procedure manual and truthfully determine how many of the potential services are actually provided in their offices. Is the reason these services are lost to the customers/patients due to the lack of knowledge of the dentist? Do we need more customers/patients or an increase in our prices to provide for the financial wellbeing of our practice or do we need the ability to diagnose and provide ethical treatment? The OAGD supports dentists in obtaining the knowledge and skills needed for successful careers. The OAGD not only provides avenues for the development of dentists as clinical experts, but also offers dentists leadership development. This leadership development transfers to community leadership as well.
